


# 7th Court of Appeals Update

Caught my one fish over Spring Break. Maybe I need to try different bait. Anyway, it's time to get back to work.

Being lawyers, you have undoubtedly been approached by a friend and asked to get them out of a traffic ticket. The usual response is "plead guilty and ask for deferred adjudication and it will not show up on your record." Well... that avenue is not available to everyone. For instance, in In re State, No. 07-16-00052-CR, 2016 Tex. App. LEXIS 2777 (Tex. App. - Amarillo, March 16, 2016), we recognized that a municipal court judge or a justice of the peace cannot grant deferred adjudication to someone who committed a traffic offense and carries a commercial driver's license. Of import though is our conclusion that the same prohibition applies to county court at law judges if the matter is appealed to them for a de novo trial. Remember that the next time you agree to help someone caught speeding.



We are always talking about "standards of review"; so, why not do it again. How about the one applicable when a party that had the burden to prove an issue (e.g., a plaintiff who has to prove the elements of his claim or a defendant who has to prove an affirmative defense) loses at trial and contends, on appeal, that the decision is legally and factually insufficient. Still awake? If so, then take a look at Siwell, Inc. v. Watts, No. 07-15-00063-CV, 2016 Tex. App. LEXIS 503 (Tex. App. - Amarillo January 19, 2016). The standard involves a two-step process. First, we search the record to see if more than a scintilla of evidence supports the decision of the factfinder (e.g., regarding the plaintiff's fraud claim. . . is there some evidence that the defendant did not misrepresent a material fact). If no such evidence is found, that does not mean the party wins. At that point, the second step comes into play, and we search the record to see if the party who had the burden proved each element of the claim or defense "as a matter of law." Pretty tough standard to meet and it's kind of like having to prove you were entitled to a summary judgment.

Remember that feeling you get upon receiving notice of a default judgment being entered against your client? You know you filed an answer but didn't know of the trial setting. Well, if you were not sent notice then the default can be set aside via a timely motion for new trial. The problem comes in proving the lack of notice since it is presumed that notice was sent and you received it. So the burden is on you to rebut that presumption via competent evidence, not mere allegations or conclusions. That was the situation we addressed in Mostue v. Mangold, No. 07-15-00402-CV, 2016 Tex. App. LEXIS 3393 (Tex. App. - Amarillo, March 31, 2016). The attorney's statement there that he may or may not have received notice but he didn't think he did was not enough.


# Young Lawyer of the Month: John Hinders
