Let's Hear It for Paralegals!

The practice of law has been enhanced over the years by the increased use of para-professionals. I have always been confused about whether they should be referred to as "paralegals" or "legal assistants."

In 2005, the State Bar Board of Directors clarified this area by adopting a new definition for "Paralegal:"

A paralegal is a person, qualified through various combinations of education, training, or work experience, who is employed or engaged by a lawyer, law office, governmental agency, or other entity in a capacity or function which involves the performance, under the ultimate direction and supervision of a licensed attorney, of specifically delegated substantive legal work, which work, for the most part, requires a sufficient knowledge of legal principles and procedures that, absent such person, an attorney would be required to perform the task.

In April 2006, the State Bar Board of Directors adopted certain standards which are intended to assist the public in obtaining quality legal services, to assist attorneys in the utilization of their paralegals, and to assist judges in determining whether paralegal fees are recoverable as part of attorney's fees. These standards are not binding on lawyers, but lawyers are encouraged to consider as a paralegal only those professionals who (i) have received legal instruction from a formal education program, (ii) have recognized certifications, and/or (iii) have a minimum of four years work experience in performing substantive legal work, as opposed to clerical or administrative work. See www.txpd.org for further information.

The Paralegal Division of the State Bar is working hard to educate the public and legal professionals about paralegal skills and their ethical standards. I encourage lawyers to use the term "paralegal" as appropriate, and to use it consistently, as this will further that goal. And by the way, tell your paralegal "thanks" today.

A Bit of AABA History

continued from last month

...An amendment to reduce the annual dues from \$5.00 to \$2.50 per member evoked "various points of order" and "innumerable parliamentary questions" with the results that the amendment, principally championed by the younger members of the bar, was narrowly defeated. The 1912 first annual banquet of the Association was held at the Amarillo Hotel, then located on the southwest corner of Polk Street and Third Avenue.

By 1922, the Association had begun holding regular monthly luncheons and round table discussions of various subjects, thus greatly increasing the interest of the members of the Bar in the Association. In 1928, the Association admitted its first female member, Mrs. Hattie Martin Harper. By 1929, the membership of the Association had grown to 90 lawyers.

In July, 1929, the Amarillo Bar Association hosted the 48th annual convention of the Texas Bar Association which was a joint meeting with the New Mexico Bar Association and the Texas Appellate Judges Association. A reported 300 lawyers attended this joint meeting. *To be continued...*


PFLA Meeting
