## OCTOBER SPEAKER: MARK WERBNER



Mark Werbner

Mark Werbner will be our speaker at the October 13 luncheon. Mark served as lead counsel in Terror Victims v. Arab Bank. For ten years, Mark pursued the Jordan Arab Bank for financing terrorist attacks by Hamas against Israel. Mark represented the families of 100 U.S. residents who were murdered or seriously injured by suicide bombers during the Second Intifada. Mark's firm spent more than \$5,000,000 in expenses and incurred over \$8,000,000 in billable time since filing the suit in 2004. In 2014, Mark helped convince a New York federal jury to issue liability findings against Arab Bank, clearing the way for financial damages at trial. The verdict represented the first time in U.S. history that a foreign bank has been found liable for materially supporting terrorism. This groundbreaking case on international terrorism has been featured on the Fox News Channel, Court TV, The Wall Street Journal and other national and international media.

Mark was born in San Antonio to a Jewish family that escaped Czarist Russia. He obtained his undergraduate degree from the University of Texas and his law degree from the SMU School of Law. Mark is Board Certified in both civil trial law and criminal law. In 1994, Mark co-founded Sayles Werbner, an eleven-lawyer litigation boutique firm based in Dallas with international reach. One of the nation's most respected trial lawyers, Mark enjoys a diverse practice in high-stakes litigation that includes business litigation, white-collar criminal defense, catastrophic personal injuries and wrongful death cases. With over 150 jury trials throughout Texas and across the United States, Mark has developed a reputation for excellence in the courtroom. Mark has won over a dozen jury verdicts of \$1,000,000 or more and one verdict exceeding \$400,000,000. He received the Dallas Bar Association Trial Lawver of the Year Award in 2011 and has been listed in The Best Lawyers in America from 1999 to 2016. Mark has been recognized as a Texas Super Lawver from 2003 to 2016 and has been recognized as a Texas Super Lawyer Top 10 four times.

## 7th Court of Appeals Update

There's nothing like typing something up, hitting the wrong key, and watching it evaporate into the cyber void. Here's my second attempt at this month's submission.

In the words of my Pa, "if that apple ain't ripe, don't eat it." The apple I'm talking about is the dispute tangled in front of the trial court. You know that the court doesn't have the ability to adjudicate everything brought before it. There's this thing we all learned about called subject matter-jurisdiction, and while it has several components, the one implicated in *Harrington v. Lone Star NGL Pipeline LP*, No. 07-15-00272-CV, 2016 Tex. App. LEXIS 8228 (Tex. App.—Amarillo July 29, 2016) was ripeness. Simply said, only a ripe dispute triggers our authority to act, and it's ripe when there exists a real,

substantial controversy involving a genuine conflict of tangible interests, and not merely a theoretical debate. This applies to declaratory actions, too. The piece of fruit tangled in front of the trial court in Harrington was a suit by various landowners against NGL Pipeline to obtain a declaration of the parties' respective rights under a pipeline easement. But, NGL had disclaimed its rights under the easement. In effect, there was no real and substantial controversy between the parties, and, therefore, the trial court lacked subject matter jurisdiction to adjudicate the non-argument. Because the apple was not ripe, it couldn't be et ... yeah, I said "et."

As a renowned trial judge once said, the job of an appellate court is "to walk the battlefield once the fight is over and bayonet the wounded." love John Forbis, may he rest in peace. In walking the battlefield after the war, we survey what was done before we got there. Putting that in the perspective, we do not try cases but review that done in and by the trial court. So, it is the obligation of the appellant to provide us with the record of the battle. And, that record must be sufficient to show that wrong was done, i.e. that reversible error occurred. In In re CEK, No. 07-15-00462, 2016 Tex. App. LEXIS 9324 (Tex. App. - Amarillo August 24, 2016), the issue involved the sufficiency of the evidence supporting the trial court's decision to terminate the parental rights of a father. Missing from the record, though, was a report considered by the trial court in making its decision. Satisfying the appellant's obligation described above meant that the father had to provide us with all ... I mean all ... the evidence before the court; otherwise, we had to presume that the missing information supported the decision. And, we did just that. Because part of the battle's record was missing, we could not say that a wrong occurred. A tough result in a tough fight.

As Ferris said: "Life moves pretty fast. If you don't stop and look around once in a while, you could miss it." I think I'm gonna look around now.
