

September Program: Legislative Update



Sen. Kel Seliger

The 85th Texas Legislative Session is on the horizon for 2017. What substantial pieces of legislation will likely be considered? What are the likely changes in Texas law that may have an effect on our civil or criminal practices? Here to discuss these issues are two of our representatives in the 85th Legislature: Sen. Kel Seliger and Rep. John Smithee.

Sen. Kel Seliger represents Senate District 31, which currently spans 37 counties from the Panhandle to the Permian Basin and includes Amarillo, Midland, Odessa, and Big Spring. Sen. Seliger serves as Chairman of the Senate Higher Education Committee and is a member of the Senate Education Committee, Senate Finance Committee, Senate Committee on Natural Resources and Economic Development, the Senate Committee on Business and Commerce and the Select Committee on Government Facilities. Sen. Seliger received the Texas Municipal League 2015 Leg-

islator of the Year Award. Sen. Seliger was first elected to the Texas Senate in 2004. Prior to his election to the Texas Senate, Sen. Seliger served four terms as Mayor of Amarillo and as a member of the Amarillo City Commission and the Amarillo Civil Service Commission.



Rep. John Smithee

Rep. John Smithee represents House District 86, which includes Randall, Dallam, Hartley, Oldham, Deaf Smith, and Parmer counties. Rep. Smithee is Chairman of the House Judiciary and Civil Jurisprudence Committee and serves on the State Affairs Committee. Rep. Smithee was first elected to the Texas House in 1984 at the age of thirty-three and has served the people of House District 86 since then. District 86 is now considered the most Republican House jurisdiction in the entire state.

I hope that you will join our representatives at our September 8 meeting for this important update from the Texas Legislature!

Amarillo to Observe Sixth Annual Red Mass

All judges of the Texas Panhandle will be the guests of honor at the Sixth Annual Red Mass Ceremony on Tuesday, October 11, 2016 at 6:30 p.m. at St. Mary's Cathedral, 1200 S. Washington in Amarillo. All attorneys are invited and encouraged to attend. Sponsored by the Roman Catholic Diocese of Amarillo, the Red Mass is a centuries-old tradition that marks the official opening of the judicial year. The service promotes the unity of the judiciary and the legal profession and invokes the blessing of the Holy Spirit on the judiciary and the judicial system. Because the color red is traditionally symbolic of the Holy Spirit, the liturgy has become known as "the Red Mass." God is called upon for his blessings on the administration of justice and for those whose duty it is to judge, teach and resolve legal matters.

A Red Mass is held each October in Washington, D.C. to mark the opening of the term of the United States Supreme Court. Many dioceses in the country therefore celebrate their Red Mass in October as well. The Red Mass is open to all judges, lawyers, public officials, and anyone in the community with a concern for justice, regardless of

religious background.

Bishop Patrick J. Zurek, Bishop of Amarillo, will serve as principal celebrant, and the Mass will be followed by a keynote address from Dr. Michael Scaperlanda, President of St. Gregory's University. Dr. Scaperlanda previously served in several different roles at The University of Oklahoma College of Law, including Associate Dean for Research and Associate Dean for Academics, and he is well-published on the intersection of constitutional law and immigration law. Dr. Scaperlanda also speaks frequently on the role of courts in shaping our constitutional community and the place of religion in the public square.

A reception with heavy hors d'oeuvres, beer and wine will follow the Mass. Dress attire is business attire, and everyone is encouraged to wear red accents.

7th Court of Appeals Update

Summer is over . . . well, almost. Too bad no one has learned how to put time in a bottle. I'd try to save every day just like Jim Croce wanted to do . . . or at least slow them down.

How about a criminal law refresher . . . ? Defendants are often granted deferred adjudication and placed on probation. Any complaint they have up to that point has to be appealed at that time. If they wait until their probation is revoked to raise those complaints, it's too late. There are exceptions to the rule, but they involve jurisdictional or other issues that render void the order placing the defendant on deferred adjudication. Many do not think about appealing, most likely because their client is pleased with getting probation. Take a look at Jimenez v. State, No. 07-16-00104-CR (Tex.

Another end of summer refresher . . . dealing with final judgments and appellate jurisdiction. The trial court held a hearing on a motion for a temporary injunction. Only argument was presented, however, and the judge concluded the proceeding by stating that "the injunction [was] continued." About a week later, the parties discovered that the trial court signed a decree ordering a "permanent injunction." The party against whom the injunction was issued appealed. Aside from the obvious questions like "can you get a permanent injunction at a hearing on a temporary injunction" or "can you get a permanent injunction after a hearing where no evidence is presented," the issue before us dealt with whether the order was final. We concluded that it was not. All the claims and parties were not addressed in the decree. Nor was the decree entitled to a presumption of finality given that it arose from something less than a trial. And, it was not enough to simply say that a permanent injunction is granted. Green v. Memorial Park Med. Ctr., Inc., No. 07-15-00143-CV, 2016 Tex. App. LEXIS 3111 (Tex. App. -Amarillo March, 25, 2016). Make sure all the claims by all the parties have been addressed and you will not have to explain to your client why you are playing in the trial court again. If not, you give us an easy way to dispose of the appeal.

The older I get, the harder it is to think. So, I am ending it with just two this month. Now, where's that bottle . . . to catch time, that is.




Young Lawyer of the Month: Suzannah McCord
