Mick McKamie

At our September meeting, Amarillo City Attorney Mick McKamie will present: Hot Topics in Municipal Law in Amarillo and throughout Texas. McKamie is a civil trial lawyer who has spent a significant portion of his career representing governmental entities. McKamie has served as the Amarillo City Attorney a little more than a year and served another year before that as the Interim City Attorney. McKamie has addressed numerous issues at the City of Amarillo and beyond, and his stories of trials, hearings, administrative proceedings, and all other matters for many municipalities across Texas are both

entertaining and educational to attorneys across all practice areas.

McKamie is a graduate of the University of Texas and Texas Tech University School of Law. He also earned a Masters Degree in Public Administration from Texas Tech University. McKamie is a former Assistant City Attorney for Lubbock (1979-81) and City Attorney for Greenville (1983-87). He has also served as City Attorney for the Home Rule Cities of Alpine, Boerne, Hondo, and the General Law Cities of Leon Valley, Richwood, Somerville, Ferris and Cottonwood Shores. He has served as Interim City Attorney for the City of Euless and for the City of Forney, and as General Counsel for the Laredo Housing Authority.

McKamie is a frequent speaker and panelist on municipal and public law issues, focusing on Open Government, land use litigation, annexation and boundary disputes, governmental and official immunity, Fair Housing, Whistleblower **EEOC** Act. employment discrimination, damages and remedies issues, and complex civil litigation. He is an Original Member of the Housing Authority Defense Attorneys Association.

McKamie has over 50 reported State and Federal Appellate decisions as lead counsel. Come listen to him regale us with stories of municipal law and cities in search of legal solutions to their problems.



7th Court of Appeals Update

There ain't no cure for the summertime blues, supposedly. What about the end of Summer when you're left wondering where it went. Seems like there ain't no cure for the "where in the heck did Summer go" blues neither. Despite having dem blues every year around dis time, I guess I best just write.

When you want the trial court to do something, you better be able to help it decide you're right. In Keenum v. State, No. 07-16-00111-CR, 2017 Tex. App. LEXIS 6534 (Tex. App. - Amarillo July 14, 2017), appellant's trial attorney wanted the trial judge to add an instruction on a lesser-included offense in its jury charge. When the trial judge asked the attorney if he could point to evidence entitling him to the charge, counsel said he could not. We viewed this response as effectively estopping appellant from contending on appeal that evidence warranted submission of the instruction. In short, the appellant gave the trial court reason to deny the request; so he had no reason to complain on appeal.

Caps, caps, and more caps, and I'm not talking the kind that cover your head. We know that statute caps monetary tort recoveries against governmental entities, but who falls under those caps? In Anderson v. Stiniker, No 07-16-00214-CV, 2017 Tex. App. LEXIS 6991 (Tex. App. - Amarillo July 26, 2017), we were asked if a private physician working in the emergency room of a government hospital did. Our answer was ves. It appears that the legislature expressly said so, even though his colleagues working in other areas of the same hospital may not be entitled to the protection.

We all push other people's buttons sometimes. Doing that to a

judge, though, can result in contempt. And, if it happens that you are involved in a criminal case when that button is pushed and you hear the words "I find you in contempt and sentence you to a rest in jail," don't come to us looking for the keys to that jail cell. We do not have original habeas corpus jurisdiction

when one is cited for contempt in criminal cases, as we noted in In re Spriggs, No. 07-17-00266-CR, 2017 Tex. App. LEXIS 7438 (Tex. App. – Amarillo August 7, 2017). Only the Court of Criminal Appeals can set you free then.

AMARILLO TO OBSERVE SEVENTH ANNUAL RED MASS

All judges of the Texas Panhandle will be the guests of honor at the Seventh Annual Red Mass Ceremony on Tuesday, September 26, 2017, at 6:30 p.m. at St. Mary's Cathedral, 1200 S. Washington in Amarillo. We invite, and encourage, all attorneys to attend. Sponsored by the Roman Catholic Diocese of Amarillo, the Red Mass is a centuries-old tradition that marks the official opening of the judicial year. The service promotes the unity of the judiciary and the legal profession and invokes the blessing of the Holy Spirit upon the judicial system, the judiciary and those whose duty it is to judge, teach and resolve legal matters in the pursuit of justice. Because the color red is traditionally symbolic of the Holy Spirit, the liturgy has become known as "the Red Mass."

A Red Mass is held each October in Washington, D.C., to mark the opening of the term of the United States Supreme Court. Many dioceses in the country, therefore, celebrate their Red Mass in October as well. The Red Mass is open to all judges, lawyers, public officials, law enforcement and anyone in the community with a concern for justice, regardless of religious background. We welcome everyone into the church for this very special Mass celebration.

Bishop Patrick J. Zurek of Amarillo will serve as principal celebrant, and the Mass will be followed by a keynote address from Federal Magistrate Judge Renee H. Toliver of Dallas. Judge Toliver has served as a Federal Magistrate Judge in the Northern District of Texas, Dallas Division, since 2010. Judge Toliver is a 1981 graduate of Howard University and a 1984 graduate of the University of Texas School of Law. Judge Toliver grew up poor and endured very challenging circumstances, but with the guidance of her mother and grandmother, she excelled in school and has worked her way up to her current position. Judge Toliver was the first African-American magistrate judge for the Northern District of Texas. Judge Toliver's story is inspiring, and we look very forward to her presentation.

A reception with heavy hors d'oeuvres, beer and wine will follow the Mass and keynote address. Dress attire is business attire, and everyone is encouraged to wear red accents.




